The contract entails the construction of the following components:

- 2.2 km uPVC underground pipeline
- 4 x Equipping of Boreholes
- 3 x Borehole Fencing
- 1 x Borehole Sump

It is estimated that tenderers should have a CIDB contractor grading designation of 4 CE or higher.

A compulsory site visit/clarification meeting with representatives of the Employer/Engineer will take place at municipal service point in KAMIESKROON on Wednesday 25 September 2019 starting at 12h00.

Sealed tender documents appropriately marked with the contract number and name of the project, must be deposited in the tender box of KAMIESBERG MUNICIPALITY, 22 Main Road, GARIES, before Friday, 11 October 2019 at 12:00, where the tenders will be opened in public.

Facsimile, e-mail and late tenders will not be accepted.

The Municipality reserves the right not to award the tender to the only or the lowest Tenderer. Tenders may only be submitted on the tender documentation that has been issued.

No tender offer will be considered from the following tenderers:

- a) The tenderers must comply to the CIDB-Grading Conditions
- b) Persons who were convicted for fraud or corruption during the past five years.
- c) Who wilfully neglected, reneged on or failed to comply with a government contract during the past five years.
- d) Tenderer who cannot submit a valid Tax Clearance Certificate.
- e) Tenderer who is not registered or accredited as a Contractor or a contractor according to the Central Contractor Database (CSD).
